This authorization is given on the understanding that this product control number and approved mark can only be used for laminated glass products manufactured with the Kuraray brand interlayers listed above.

Alternate manufacturing locations must submit product for their own evaluation; certifications are not transferrable between manufacturing plants or fabrication plants other than the point of original manufacture.
